Electoral Roll will be available starting 11th September 2018 and Nomination Papers will be available starting 18th September 2018 from Society Office between 1.00 pm and 5.00 pm from Monday to Friday (excepting holidays) on Payment of Rs. 1000/- for each set of Electoral Roll and Rs.100/- for each Nomination Paper.

Any queries regarding the electoral roll may be addressed to the Chief Election Commissioner in writing by 30th September, 2018 (4.00 p.m.).

Eligibility Criteria

i. Vice President - Must have been a member of the Society for a period of not less than 15 years and member of executive committee for at least one term.

ii. Honorary Secretary – Must have been a member of the Society for a period of not less than 12 years and must have served the Society as an Office Bearer of the Executive Committee at least for one term.

iii. Joint Secretary – Must have been a member of the Society for a period of seven years and must have served the Society as a member of the Executive Committee at least for one term.

iv. Honorary Treasurer - Must have been a member of the Society for a period of ten years and must have served the Society as an Office Bearer of the Executive Committee at least for one term.

v. Joint Treasurer - Must have been a member of the Society for a period of five years and must have served the Society as a member of the Executive Committee at least for one term.


vi) Scientific Committee Chairman - Must have been a member of the Society for a period of eight years and must have served the Society as an Office Bearer of the Executive Committee at least for one term.

vii) Editor Journal - Must have been a member of the Society for a period of six years and must have served the Society as a member of the Executive Committee at least for one term.

viii) Members of the Executive Committee - Must have been a Life or Ordinary member of the Society for a period of not less than three years.

ix) One or more terms for eligibility will mean completion of the term/terms at the time of taking charge of or assuming the next office/post. It will be a mandatory requirement. In circumstances where he/she has not completed the total or full eligibility term, the elected candidate will lose the right to take charge of the new office or post.

x) Only Life members will be eligible for contesting an election. As for the eligibility criterion of number of years of membership of Society, the total number of consecutive years of Life membership will be counted till the time of taking charge or assuming the elected office/post. The old category of consecutive Ordinary membership years will be included with the Life membership years while counting the total years of membership of Society.
